For Week Ending: June 30, 2024

ALASKA: There were 6.6 days suitable for fieldwork for the week ending June 30. Local hay supplies were reported at 25% short and 75% adequate. Warm and dry conditions persisted in **Kenai** leading to another week of drought stress. Irrigation was required for many crops. Favorable hay harvest conditions were reported in the **Tanana Valley** with hot and dry weather for much of the week. Barley made good progress with around half the crop in-boot. Progress was made in the first cutting of hay with reports of good quality. Other activities in the Tanana Valley included weed management, summer fallow tillage, hilling of potatoes, fence construction and maintenance. Rain was reported in the **Matanuska Valley** mid-week which slowed field work. Otherwise, conditions were generally favorable for field work. Hay progress was good with several fields baled over the week.
