## **United States Commercial Slaughter**

Commercial red meat production for the United States totaled 4.55 billion pounds in July 2024, up 10 percent from the 4.13 billion pounds produced in July 2023.

Beef production, at 2.29 billion pounds, was 8 percent above the previous year. Cattle slaughter totaled 2.72 million head, up 5 percent from July 2023.

Veal production totaled 3.30 million pounds, 11 percent below July a year ago. Calf slaughter totaled 17,600 head, down 24 percent from July 2023.

Pork production totaled 2.25 billion pounds, up 12 percent from the previous year. Hog slaughter totaled 10.7 million head, up 11 percent from July 2023.

Lamb and mutton production, at 11.3 million pounds, was up 19 percent from July 2023. Sheep slaughter totaled 185,100 head, 16 percent above last year.

## **Pacific Region Commercial Slaughter**

California's production of red meat during July 2024 totaled 95.1 million pounds (dressed weight), 10 percent below than July 2023. This figure includes slaughter in Federally-inspected and state-inspected plants, but excludes farm slaughter. In July 2024, the average live weight of cattle slaughtered in California was 1,330 pounds, sheep and lambs averaged 143 pounds, and hogs averaged 226 pounds. In Hawaii, 800,000 pounds of red meat were produced in July 2024, and 100,000 pounds of red meat were produced in Nevada.
