KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. August 9, 2021 - For the week ending August 8, 2021, there were 6.3 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 11% very short, 37% short, 51% adequate, and 1% surplus. Subsoil moisture supplies rated 9% very short, 36% short, 54% adequate, and 1% surplus.

Field Crops Report: Corn condition rated 2% very poor, 7% poor, 26% fair, 54% good, and 11% excellent. Corn silking was 93%, near 94% for both last year and the five-year average. Dough was 62%, near 65% last year and 60% average. Dented was 12%, behind 24% last year and 20% average.

Soybean condition rated 1% very poor, 6% poor, 33% fair, 54% good, and 6% excellent. Soybeans blooming was 80%, near 84% last year and 82% average. Setting pods was 49%, behind 63% last year, and near 53% average.

Sorghum condition rated 2% very poor, 6% poor, 30% fair, 56% good, and 6% excellent. Sorghum headed was 59%, near 60% last year and 56% average. Coloring was 9%, near 8% last year and 7% average.

Cotton condition rated 0% very poor, 10% poor, 40% fair, 44% good, and 6% excellent. Cotton squaring was 87%, near 89% last year and 84% average. Setting bolls was 65%, well ahead of 38% last year and 35% average. Bolls opening was 4%, near 1% both last year and average.

Pasture and Range Report: Pasture and range conditions rated 4% very poor, 11% poor, 36% fair, 46% good, and 3% excellent.
