KANSAS CROP PROGRESS AND CONDITION

MANHATTAN, Kan. July 1, 2024 - For the week ending June 30, 2024, there were 5.5 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 8% very short, 22% short, 64% adequate, and 6% surplus. Subsoil moisture supplies rated 9% very short, 27% short, 61% adequate, and 3% surplus.

Field Crops Report: Winter wheat mature was 98%, well ahead of 74% last year, and ahead of 85% for the five-year average. Harvested was 80%, well ahead of 39% last year and 49% average.

Corn condition rated 2% very poor, 7% poor, 34% fair, 44% good, and 13% excellent. Corn silking was 30%, ahead of 15% last year and 13% average.

Soybean condition rated 1% very poor, 3% poor, 27% fair, 58% good, and 11% excellent. Soybeans planted was 98%, near 95% both last year and average. Emerged was 90%, near 89% last year and 88% average. Blooming was 7%, behind 13% last year, and near 10% average.

Sorghum condition rated 2% very poor, 5% poor, 39% fair, 46% good, and 8% excellent. Sorghum planted was 93%, ahead of 84% last year, and near 92% average. Headed was 1%, near 4% last year and 3% average.

Cotton condition rated 0% very poor, 7% poor, 37% fair, 38% good, and 18% excellent. Cotton squaring was 47%, ahead of 38% last year and 33% average. Setting bolls was 1%, near 3% last year, and equal to average.

Sunflowers planted was 88%, near 85% last year and 86% average.

Pasture and Range Report: Pasture and range conditions rated 4% very poor, 9% poor, 30% fair, 47% good, and 10% excellent.
