## KANSAS CROP PROGRESS AND CONDITION

**MANHATTAN, Kan. July 8, 2024** - For the week ending July 7, 2024, there were 4.5 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 5% very short, 15% short, 70% adequate, and 10% surplus. Subsoil moisture supplies rated 7% very short, 21% short, 68% adequate, and 4% surplus.

**Field Crops Report:** Winter wheat harvested was 92%, well ahead of 55% last year and 72% for the five-year average.

Corn condition rated 2% very poor, 5% poor, 28% fair, 47% good, and 18% excellent. Corn silking was 47%, ahead of 31% last year, and well ahead of 27% average. Dough was 4%, near 3% last year and 2% average.

Soybean condition rated 0% very poor, 3% poor, 23% fair, 55% good, and 19% excellent. Soybeans emerged was 95%, near 94% both last year and average. Blooming was 17%, behind 27% last year and 22% average. Setting pods was 1%, behind 7% last year, and near 3% average.

Sorghum condition rated 2% very poor, 5% poor, 35% fair, 45% good, and 13% excellent. Sorghum planted was 96%, ahead of 91% last year, and equal to average. Headed was 4%, near 7% last year and 6% average.

Cotton condition rated 0% very poor, 7% poor, 36% fair, 39% good, and 18% excellent. Cotton squaring was 63%, ahead of 52% last year and 47% average. Setting bolls was 7%, near 4% last year and 3% average.

Sunflowers planted was 90%, near 87% last year and 91% average.

**Pasture and Range Report:** Pasture and range conditions rated 3% very poor, 7% poor, 28% fair, 48% good, and 14% excellent.
