**Maryland** egg production totaled 67.8 million during October 2024, up 7 percent from last year. Production included 66.2 million table eggs, and 1.6 million hatching eggs. The total number of layers during October 2024 averaged 2.53 million, up 6 percent from last year. October egg production per 100 layers was 2,681 eggs, up 2 percent from October 2023.

**New York** egg production totaled 147.3 million during October 2024, about the same as last year. The total number of layers during October 2024 averaged 5.69 million, up slightly from last year. October egg production per 100 layers was 2,588 eggs, down slightly from October 2023.

**Pennsylvania** egg production totaled 708.0 million during October 2024, up 1 percent from last year. Production included 660.3 million table eggs, and 47.7 million hatching eggs. The total number of layers during October 2024 averaged about 27.2 million, down 1 percent from last year. October egg production per 100 layers was 2,604 eggs, up 3 percent from October 2023.
