**Maryland** egg production totaled 62.5 million during September 2024, up 1 percent from last year. Production included 60.9 million table eggs, and 1.6 million hatching eggs. The total number of layers during September 2024 averaged 2.43 million, up 2 percent from last year. September egg production per 100 layers was 2,572 eggs, down 1 percent from September 2023.

**New York** egg production totaled 144.1 million during September 2024, up 1 percent from last year. The total number of layers during September 2024 averaged 5.67 million, up 1 percent from last year. September egg production per 100 layers was 2,541 eggs, unchanged percent from September 2023.

**Pennsylvania** egg production totaled 695.8 million during September 2024, up 3 percent from last year. Production included 648.5 million table eggs, and 47.3 million hatching eggs. The total number of layers during September 2024 averaged about 27.1 million, down slightly percent from last year. September egg production per 100 layers was 2,567 eggs, up 3 percent from September 2023.
