

Missouri Hogs and Pigs

Released December 23, 2024

Missouri inventory of all hogs and pigs on December 1, 2024 was 3.50 million head, up 1 percent from September 1, 2024 and up 13 percent from last year. **Breeding inventory**, at 440,000 head, was up 20,000 from the previous quarter and up 10,000 from last year. **Market hog inventory**, at 3.06 million head, was up 1 percent from last quarter and up 15 percent from last year.

The September-November 2024 pig crop, at 2.75 million head, was up 12 percent from 2023. Sows farrowing during this period totaled 225,000 head, up 15,000 from a year ago. The average pigs saved per litter was 12.20 for the September-November period, compared with 11.70 last year.


