# Pacific Region Livestock Slaughter

## United States Commercial Slaughter

Commercial red meat production for the United States totaled 4.59 billion pounds in May 2023, up 2 percent from the 4.49 billion pounds produced in May 2022.

Beef production, at 2.31 billion pounds, was 1 percent above the previous year. Cattle slaughter totaled 2.84 million head, up 1 percent from May 2022.

Veal production totaled 4.2 million pounds, 7 percent below May a year ago. Calf slaughter totaled 24,200 head, down 12 percent from May 2022.

Pork production totaled 2.27 billion pounds, up 4 percent from the previous year. Hog slaughter totaled 10.6 million head, up 5 percent from May 2022.

Lamb and mutton production, at 11.4 million pounds, was up 6 percent from May 2022. Sheep slaughter totaled 186,500 head, 13 percent above last year.

## Pacific Region Commercial Slaughter

California's production of red meat during May 2023 totaled 114.2 million pounds (dressed weight), 19 percent below May 2022. This figure includes slaughter in Federally-inspected and state-inspected plants, but excludes farm slaughter. In May 2023, the average live weight of cattle slaughtered in California was 1,351 pounds, sheep and lambs averaged 150 pounds, and hogs averaged 220 pounds. In Hawaii, 700 thousand pounds of red meat were produced in May 2023, and 100 thousand pounds of red meat were produced in Nevada.
