According to the National Agricultural Statistics Service in New Jersey, there were 6.5 days suitable for fieldwork for the week ending Sunday, August 4, 2024. Topsoil moisture supplies were 20 percent short, 79 percent adequate, and 1 percent surplus. Subsoil moisture supplies were 2 percent very short, 44 percent short, 52 percent adequate, and 2 percent surplus. Pasture conditions were 1 percent very poor, 5 percent poor, 52 percent fair, 41 percent good, and 1 percent excellent.
