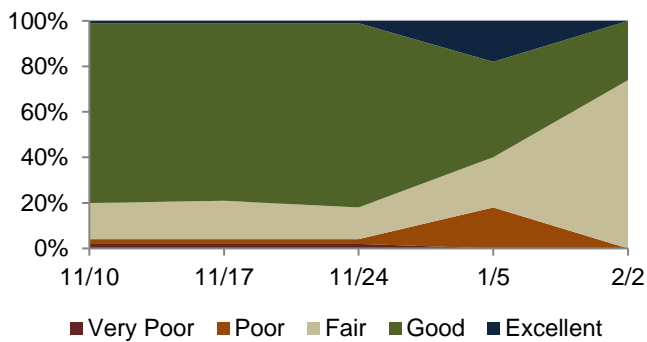

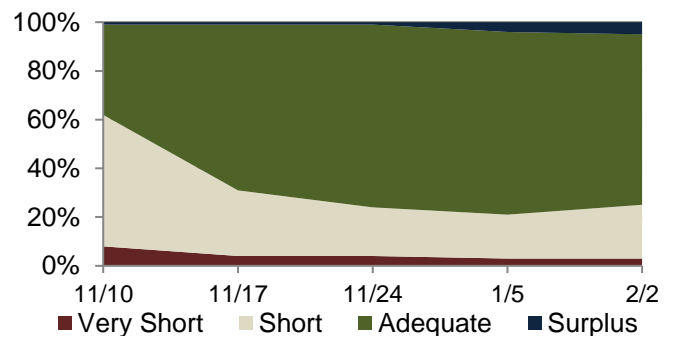

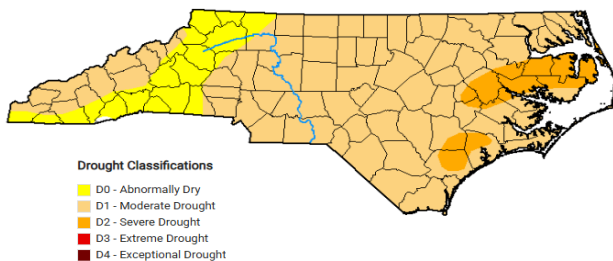
BARLEY CONDITION



TOPSOIL MOISTURE PERCENT

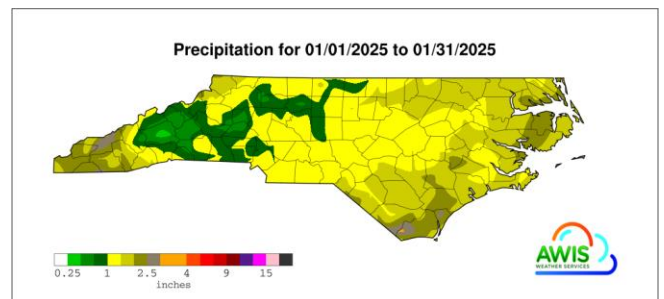


Map depicts current drought conditions as of January 28, 2025.
