NORTH DAKOTA CROP PROGRESS AND CONDITION

FARGO, N.D. May 6, 2024 - For the week ending May 5, 2024, there were 2.7 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 5% very short, 16% short, 70% adequate, and 9% surplus. Subsoil moisture supplies rated 6% very short, 24% short, 64% adequate, and 6% surplus.

Field Crops Report: Soybeans planted was 3%, near 2% for the five-year average.

Spring wheat planted was 32%, well ahead of 9% last year, and ahead of 20% average. Emerged was 5%, near 3% average.

Durum wheat planted was 21%, ahead of 5% last year and 12% average. Emerged was 1%.

Winter wheat condition rated 1% very poor, 3% poor, 38% fair, 53% good, and 5% excellent. Winter wheat jointed was 12%, ahead of 7% last year, but near 16% average.

Corn planted was 11%, ahead of 1% last year, and near 7% average.

Canola planted was 10%, ahead of 2% last year, and near 6% average.

Sugarbeets planted was 78%, well ahead of 1% last year and 25% average.

Oats planted was 24%, ahead of 5% last year and 14% average. Emerged was 3%, near 1% average.

Barley planted was 23%, ahead of 5% last year and 16% average. Emerged was 3%, near 2% average.

Dry edible peas planted was 27%, well ahead of 6% last year, and ahead of 14% average. Emerged was 3%.

Flaxseed planted was 5%, near 1% last year and 4% average.

Potatoes planted was 17%. Emerged was 1%.

Dry edible beans planted was 1%.

Pasture and Range Report: Pasture and range conditions rated 2% very poor, 6% poor, 31% fair, 55% good, and 6% excellent.

Stock water supplies rated 3% very short, 16% short, 77% adequate, and 4% surplus.
