Ohio June 1 Grain Stocks

On June 1, 2024, Ohio corn stocks totaled 250 million bushels, 24 percent above a year earlier, according to Ben Torrance, State Statistician, USDA NASS, Ohio Field Office. About 56 percent of the corn was stored on farms. The third quarter disappearance was 164 million bushels, compared with 172 million bushels a year earlier. Soybean stocks on June 1, 2024, were 76.6 million bushels. That was 25 percent higher than stocks a year earlier. Farm stocks of soybeans were 39.0 million bushels. The third quarter indicated disappearance was 55.9 million bushels, compared with 85.5 million bushels the same period a year ago. Wheat stocks on June 1, 2024, were 34.6 million bushels, 28 percent above a year ago. Fourth quarter indicated disappearance was 12.8 million bushels, compared with 12.8 million bushels last year. About 98 percent of wheat stocks were in commercial storage.

Nationally, corn stocks in all positions on June 1, 2024 totaled 4.99 billion bushels, up 22 percent from June 1, 2023. Of the total stocks, 3.03 billion bushels are stored on farms, up 37 percent from a year earlier. Off-farm stocks, at 1.97 billion bushels, are up 4 percent from a year ago. The March - May 2024 indicated disappearance is 3.36 billion bushels, compared with 3.29 billion bushels during the same period last year. Soybeans stored in all positions on June 1, 2024 totaled 970 million bushels, up 22 percent from June 1, 2023. On-farm stocks totaled 466 million bushels, up 44 percent from a year ago. Off-farm stocks, at 504 million bushels, are up 6 percent from a year ago. Indicated disappearance for the March - May 2024 quarter totaled 875 million bushels, down 2 percent from the same period a year earlier. Old crop all wheat stored in all positions on June 1, 2024 totaled 702 million bushels, up 23 percent from a year ago. On-farm stocks are estimated at 139 million bushels, up 12 percent from last year. Off-farm stocks, at 563 million bushels, are up 27 percent from a year ago. The March - May 2024 indicated disappearance is 387 million bushels, up 4 percent from the same period a year earlier.
