Milk production in **New York** during October 2024 totaled 1.35 billion pounds, up 0.2 percent from October 2023. The average milk price received by New York farmers in September 2024, at \$25.90 per hundredweight, is \$1.70 higher than August 2024 and \$3.60 higher than September a year ago.

Milk production in **Pennsylvania** during October 2024 totaled 802 million pounds, up 0.6 percent from October 2023. The average milk price received by Pennsylvania farmers in September 2024, at \$25.70 per hundredweight, is \$1.60 higher than August 2024 and \$4.00 higher than September a year ago.

Milk production in **Vermont** during October 2024 totaled 208 million pounds, down 0.5 percent from October 2023. The average milk price received by Vermont farmers in September 2024, at \$26.10 per hundredweight, is \$1.60 higher than August 2024 and \$3.90 higher than September a year ago.
