SOUTH DAKOTA CROP PROGRESS AND CONDITION

SIOUX FALLS, S.D. October 15, 2024 - For the week ending October 13, 2024, there were 6.8 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 30% very short, 43% short, 27% adequate, and 0% surplus. Subsoil moisture supplies rated 24% very short, 37% short, 39% adequate, and 0% surplus.

Field Crops Report: Corn condition rated 2% very poor, 7% poor, 22% fair, 57% good, and 12% excellent. Corn mature was 90%, behind 96% last year, but near 86% for the five-year average. Harvested was 33%, near 34% last year, and equal to average.

Soybeans dropping leaves was 98%, near 99% last year and 97% average. Harvested was 77%, ahead of 65% last year and 62% average.

Winter wheat planted was 85%, near 88% last year and 89% average. Emerged was 48%, behind 53% last year and 54% average.

Sorghum condition rated 2% very poor, 20% poor, 20% fair, 57% good, and 1% excellent. Sorghum mature was 95%, near 99% last year, but ahead of 90% average. Harvested was 53%, ahead of 46% last year and 48% average.

Sunflower condition rated 5% very poor, 6% poor, 30% fair, 54% good, and 5% excellent. Sunflowers ray flowers dry was 97%. Bracts turned yellow was 95%, near 99% last year. Bracts turned brown was 82%, ahead of 76% last year. Harvested was 15%, ahead of 8% last year, and near 14% average.

Pasture and Range Report: Pasture and range conditions rated 20% very poor, 33% poor, 23% fair, 23% good, and 1% excellent.
