SOUTH DAKOTA CROP PROGRESS AND CONDITION

SIOUX FALLS, S.D. October 28, 2024 - For the week ending October 27, 2024, there were 6.8 days suitable for fieldwork, according to the USDA's National Agricultural Statistics Service. Topsoil moisture supplies rated 36% very short, 46% short, 18% adequate, and 0% surplus. Subsoil moisture supplies rated 31% very short, 44% short, 25% adequate, and 0% surplus.

Field Crops Report: Corn harvested was 78%, well ahead of 57% last year, and ahead of 59% for the five-year average.

Soybeans harvested was 96%, near 93% last year, and ahead of 87% average.

Winter wheat condition rated 3% very poor, 13% poor, 40% fair, 40% good, and 4% excellent. Winter wheat planted was 95%, near 96% last year and 98% average. Emerged was 66%, behind 76% last year and 78% average.

Sorghum harvested was 81%, ahead of 74% last year and 67% average.

Sunflower condition rated 8% very poor, 5% poor, 25% fair, 56% good, and 6% excellent. Sunflowers harvested was 42%, ahead of 31% last year and 36% average.

Pasture and Range Report: Pasture and range conditions rated 30% very poor, 24% poor, 30% fair, 16% good, and 0% excellent.
