This report contains the results from the March 2022 Hog and Pig Survey. Data provided by Oklahoma and Texas producers are the foundation of the estimates made for the Southern Plains region. We would like to thank all producers who responded to the survey. Results from the next quarterly survey will be made available June 29, 2022.

Oklahoma Highlights


The March 1, 2022 Oklahoma hog and pig inventory, at 2.06 million head, was 1 percent higher than March 2021. The number of **breeding hogs** totaled 470 thousand head, up 10 thousand from last year. The March 1 **market hog** inventory was up 1 percent from a year ago at 1.59 million head, 77 percent of the total hog and pig inventory.

The December 2021-February 2022 Oklahoma **pig crop** totaled 1.88 million head, 7 percent below last year. Pigs per litter averaged 9.7, down 4 percent from the previous year. Sows farrowed during December 2021 through February 2022 totaled 195 thousand head, down 3 percent from last year.

Texas Highlights

The March 1, 2022 Texas hog and pig inventory, at 1.00 million head, was 5 percent lower than March 2021. The number of **breeding hogs** totaled 160 thousand head, unchanged from last year. The March 1 **market hog** inventory was down 6 percent from a year ago at 840 thousand head, 84 percent of the total hog and pig inventory.

The December 2021-February 2022 Texas **pig crop** totaled 615 thousand head, 12 percent below last year. Pigs per litter averaged 10.6, up 5 percent from the previous year. Sows farrowed during December 2021 through February 2022 totaled 58.0 thousand head, down 16 percent from last year.





U.S. Highlights

The U.S. inventory of all hogs and pigs on March 1, 2022, is estimated at 72.2 million head, down 2 percent from a year ago and down 3 percent from December 1, 2021. The **breeding hog inventory**, at 6.10 million head, was down 2 percent from last year and down slightly from the previous quarter. **Market hog** inventory, at 66.1 million head, was down 2 percent from last year and down 3 percent from last quarter.

The U.S. **pig crop** for December 2021-February 2022, at 31.7 million, was down 1 percent from 2021. U.S. producers intend to have 2.99 million sows farrow during the March 2022-May 2022 period, down 2 percent from the actual farrowings during the same period last year. Intended farrowings for June 2022-August 2022, at 3.03 million sows, are down 1 percent from the same quarter the year prior.
